1. Background Information on Plan International

2. Summary of the Requirement

Plan International are inviting interested parties to submit a Proposal for Consultancy as part of a competitive process for ITT FY26-0210 Parenting and Adolescent Life Skills (PALS) Impact Evaluation. Successful Bidder(s) will be expected to enter into a formal contract on a non-exclusive basis with our organization. Plan International reserves the right not to award a contract as a result of this Invitation to Tender, or to award to multiple successful Bidders.

3. ITT Overview and Instructions

3.1 Overview

Adolescents form nearly a quarter of all people affected by humanitarian crises. Yet, the needs of adolescents in crisis are often overlooked, leaving them at risk of school drop-out, child labour and exploitation. In crisis situations, girls see their world shrink as their families restrict their mobility, limiting access to school, social support and health care. Many girls experience violence and exploitation, including child marriage, often with life-long and devastating consequences.

The Parenting and Adolescent Life Skills (PALS) programme model was developed to improve the well-being, health and safety of adolescents in crisis settings. Adolescents participate in a 13-week life skills programme that runs in parallel to a 10-week parenting programme that targets their parents and caregivers.

This parallel approach helps to reinforce three main programme outcomes:

- Adolescents learn how to promote their social and emotional wellbeing, health and safety
- Parents and caregivers learn how to promote self-care and positive parenting practices
- Adolescents and their parents/caregivers feel safe and supported.

The PALS project uses four strategies to reach these outcomes:

- Providing life-saving information to adolescents and their families in crisis settings
- Strengthening life skills of adolescents and positive parenting practices of parents/caregivers
- Promoting positive and supportive parent-child relationships
- Linking adolescents and their families to locally available services and support

PALS is a humanitarian programme model - a replicable intervention/building block for integrated programmes developed with the intent of scale - which was developed based on latest evidence and in close consultation with adolescents, parents and caregivers in humanitarian settings. Plan International implements PALS in collaboration with local organisations, youth networks and service providers, and as part of comprehensive adolescent-responsive programming. PALS is never implemented as a stand-alone project or programme. It is always embedded in broader humanitarian child protection and/or education projects and programmes.

3.2 Instructions to Tenderers

These instructions are designed to ensure that all Bidders are given equal and fair consideration. It is the Bidders responsibility to ensure their offer is complete and that you provide all the necessary information asked for in the format specified, or risk your offer being rejected. 3.4 Pricing

Bidders are required to submit Financial Proposal. All prices must be **quoted in Euros**, and exclusive of Value Added Tax (VAT).

It is expected that prices will be fixed for the duration of the contract and quotes valid for a maximum period of 90 calendar days following the Closing Date of this tender. If for any reason you are unable to guarantee fixed pricing for the duration of the contract, any projected price increases should be clearly stated in your tender.

To ensure a fair and transparent process, Plan International will not be able to divulge budget information relating to this tender or associated Projects. It is expected that Bidders submit their best possible financial offer at the point of submission.

The successful Bidder will be required to pay their staff who work on this contract **at least** the National Living Wage.

4. Specification and Scope of Requirement

4.1 Purpose and use of the evaluation

We are looking to collaborate with an experienced research institute/research consultant on an impact evaluation that seeks to assess the PALS programme model's effectiveness and contribution to long-term goals of comprehensive adolescent-responsive programming. Findings will be used to inform decision-making around programme model improvements, scaling-up PALS programming, and to foster sector-wide and cross-sector internal and external learning.

4.2 Objectives of the evaluation

- Develop an impact evaluation design based on the following questions:
 - To what extent is the PALS programme model effective in achieving its direct programme outcomes?
 - What is the PALS programme model's contribution to comprehensive adolescentresponsive programming's long-term goals (impact)?
 - What are observed positive and/or negative unintended effects of the implemented programme model?
 - o To what extent have participating groups, differentiated by gender, age and disability, benefitted equally from the intervention?
 - To what extent does the programme model successfully contribute to gender equality and inclusion of at-risk adolescents, particularly girls?
- Conduct the impact evaluation in Rubkona County, Unity State, South Sudan.
- Identify areas of improvement and provide recommendation for general programmatic improvements and specifically on improvement related to maximizing effectiveness and impact as well as strengthening gender and inclusion integration and results.

4.3 Scope of the study

The impact evaluation is expected to be conducted in Unity State, South Sudan. This part of the study will involve direct contact with children or adolescents.

5. PALS Implementation in South Sudan

Plan International's PALS programming in South Sudan aims to support adolescents' resilience, providing them with the skills and resources necessary to overcome the challenges of everyday life. The PALS programme is being implemented as part of broader education and child protection projects, where PALS is coupled with community-based psychosocial support implemented through child-friendly safe spaces and schools, child protection case management, distribution of hygiene kits and referrals to other sector services including food security.

6. Methodology

6.1 Data collection and analysis methodology

Prospective consultant(s) are expected to propose an evaluation design in line with Plan's Ethics Guidelines for Monitoring, Evaluation and Research and the above-mentioned objectives of the impact evaluation. Based on the evaluation design, the consultant(s) are expected to further suggest data collection methodologies following a mixed-methods approach. Consultants are requested to propose adolescent-friendly, and where possible adolescent-led evaluation methods, to ensure meaningful participation of adolescents in the evaluation process. Any limitations to the methods proposed should be noted in the proposal, with clear mitigation measures identified. Sources of data should be properly documented, and data disaggregated by sex, disability, age group (younger adolescents aged 10 to 14 years and older adolescents 15 to 17 years) and any other context specific relevant criteria during collection and analysis.

6.2 Data protection and quality assurance

The prospective consultant(s) are expected to provide an overview of their quality assurance and data protection plans in compliance with Plan International's Data Protection Policy, the General Data Protection Regulation (GDPR) and relevant national regulations. The use of Artificial Intelligence (AI) tools for any component of this evaluation will not be accepted.

6.3 Sampling Strategies

The consultant(s) is expected to develop and suggest sampling strategies for all proposed methods of data collection, quantitative and qualitative. Sample sizes for quantitative data collection need to be representative of the respective project participant population. For any proposed quantitative methodologies, a 95% confidence interval level with a 5% margin of error is required for sample size calculations with a minimum disaggregation by gender and age.

7. Key Deliverables

- A draft inception report including a suggested approach for the design for the impact evaluation, proposals for methodologies, ethics, safeguarding and risk considerations, and a timeline.
- A final inception report, incorporating feedback from Plan International.

- A clear description of proposed data collection tools including adolescent-friendly, participatory tools.
- A draft impact evaluation report, including the final sampling strategy.
- Cleaned Datasets (including data sets, transcripts of qualitative data, and code books in standard formats, e.g., Excel, SPSS, NVivo, Atlas ti, etc.).
- Completed consent forms (incl. for adolescents and their caregivers).
- A validation workshop on the findings of the impact evaluation.
- A final impact evaluation report, approved by Plan International, incl. a standalone executive summary.

8. Expected qualifications

The consultant(s) should have the following qualifications and experience:

- At least a postgraduate degree in Social Sciences or another relevant field;
- Technical competence in humanitarian programming, child protection in emergencies, and gender and inclusion;
- At least 10 years of proven experience in designing, conducting and leading impact evaluations in the humanitarian sector, particularly related to child- and adolescent interventions, such as life skills and parenting interventions;
- Proficiency in qualitative and quantitative methods of data collection in humanitarian settings, including child- and adolescent-friendly and participatory methods;
- Proven experience in quantitative and qualitative data analysis;
- Excellent reporting and presentation skills;
- Valid Hostile Environment Awareness Training (HEAT) certification of no less than two years old (applicable only for in-country visiting team members);
- Fluency in English (excellent communication and writing skills);
- Experience working in South Sudan or other conflict-affected humanitarian settings.

9. Selection Criteria

Bids will be assessed against predetermined criteria which has been developed and agreed by the Tender Panel prior to launching this Tender process. The information gathered in requested documentation, will be used to evaluate and score each Bid against this set criteria. Please find further details in the below table:
