

Toolbox: Integrated Child Protection and Food Security Programming in Humanitarian Action





IF YOU ARE A FOOD SECURITY ACTOR, these tools will help you engage with child protection (CP) actors in a pragmatic and concrete way and will support you in integrating CP in your programming, as well as provide you with a basis on which to build dissemination trainings on food security (FS) to non-FS colleagues.

IF YOU ARE A CHILD PROTECTION ACTOR, these tools will help you engage with food security actors in a pragmatic and concrete way and will support you in integrating FS in your programming, as well as provide you with a basis on which to build dissemination trainings on child protection to non-CP colleagues.

This is a collection of handy tools to support child protection and food security humanitarian actors to integrate CP and FS into designing, implementing and evaluating integrated Child Protection and Food Security programs in humanitarian settings. It provides a range of tools that address the interlinkages between CP and FS, enabling practitioners to respond effectively to the complex needs of children and their families. Concrete and pragmatic, these tools have been developed based on requests from practitioners and will be tested in various contexts.

The tools within this collection are designed to be flexible and adaptable. Some are templates that can be tailored to specific contexts, while others offer step-

by-step guidance for various stages of the program cycle. They can be used individually, in any order, or in succession for a comprehensive approach to integrated programming. Regardless of how they are utilized, all tools will require contextual adaptation to ensure their relevance and effectiveness.

As this toolbox is in its testing phase, practitioners are encouraged to experiment with these tools, adapt them to their contexts and provide feedback on their utility and outcomes.
