

ABOUT SAFE ONLINE

Technology has become an integral part of people's day-to-day lives—the rise of digital era has given us the opportunity to communicate with our loved ones, facilitate meaningful discussions even with people from across the globe, and support and promote advocacies that align with our personal beliefs.

Social media provides spaces where people, including children and youth, are free to speak up, express themselves, and lead change in their respective communities. However, with our lives increasingly moving online, it's important to acknowledge that the virtual world is a vast and unregulated space that may put children and young people at risk. This is why, now more than ever, it is crucial that we take immediate actions to protect children and young people from the threats of the online world.

Plan International Philippines, together with Philippine Legislators' Committee on Population and Development (PLCPD), is implementing **SAFE Online** (Systems Approach For Ensuring Online Safety and Empowerment of Children and Young People), an EU-funded project. The SAFE Online project seeks to protect children and young people from online sexual exploitation and violence.

The project aims to empower children and young people to protect themselves and their peers from the threats of the online world and influence them to take collective action through lobbying for policies that will uphold strong protective measures.

The SAFE Online project is being implemented in the city of Manila and Bacoor in Cavite and the municipalities of Mayorga and MacArthur in Leyte given the at-risk communities and reported cases of online abuse.

FACILITATORS' TRAINING ON DIGITAL CITIZENSHIP AND ONLINE SEXUAL EXPLOITATION OF CHILDREN (OSEC) EDUCATION

In alignment with its aim to empower children and young people to become agents of change and influence child protection system actors to uphold strong protective measures against OSEC and online violence, the SAFE Online project was designed to be participatory where the project's beneficiaries work alongside Plan International Philippines and the Philippine Legislators' Committee on Population and Development (PLCPD) in achieving the overall goal of the project.

Part of the project's undertaking is the capacity building of children and young people, parents, caregivers, community leaders, child protection system actors, and private sector partners. With this, a series of Training of Facilitators on Digital Citizenship and Online Sexual Exploitation of Children (OSEC) Education were conducted in the cities of Manila and Bacoor, Cavite, and in the municipalities of MacArthur and Mayorga, Leyte from August to November 2022. The 3-day Training of Facilitators aims to equip the participants with the knowledge and skills to effectively train other people in their respective communities.

Using the participatory learning approach, the participants are expected to contribute to the learning process building on their knowledge, skills, and experiences. ■

SAFE ONLINE COMMUNITY ROLLOUTS

As part of SAFE Online's commitment to eradicate online sexual exploitation and abuse of children through collective action, the *Digital Citizenship and Online Sexual Exploitation of Children (OSEC) Education* workshops were rolled out and were attended by over 1,000 children and young people and over 2,000 child protection system actors.

The attendees consist of community leaders, healthcare workers, teaching and non-teaching personnel, police officers, lawyers, and parents—all hopeful and dedicated to keep children safe from the threats of the digital environment. The workshop's objective is to strengthen the community-based child protection mechanisms in the covered areas—which includes designing efficient and gender-transformative processes for handling child abuse cases.

WORKING TOWARDS A VIOLENCE-FREE ONLINE COMMUNITIES THROUGH LOBBYING AND COLLECTIVE ACTION

Plan International Philippines has been heavily involved in the consultations about the salient provisions of the recently passed Republic Act No. 11930 also known as the "Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act."

Joining other child and human rights organizations, Plan International Philippines shared good practices and lessons learned relevant to the implementation of the said law during a briefing with Senator Risa Hontiveros (the author and sponsor of the bill), the National Bureau of Investigation (NBI), the Philippine National Police (PNP), and tech giant Facebook Philippines on July 27, 2022.

With the recent passage of R.A. No. 11930, Plan International Philippines along with other members of the Child Rights Network (CRN), hopes that the provided suggestions during consultation series be taken into consideration and can support the proper implementation of the law.

NOV 26, 2022

Special Consultation with Children on Implementing Rules and Regulation (IRR) of R.A. No. 11930 or Anti-OSAEC and Anti-CSAEM Act

In celebration of National Children's Month, Plan International Philippines and its partner organization PLCPD participated in the special consultation with children from all over the country on the salient features of the Republic Act No. 11930 and the specific provisions in the draft Implementing Rules and Regulations (IRR) that affect children and young people.

The SAFE Online Project's youth facilitators spearheaded the discussions among their fellow youths and presented their comments and suggestions on the IRR in plenary.

The UN Special Rapporteur visited the country at the request of the Philippine Government to gain first-hand understanding of issues related to her mandate, in particular measures taken to uphold and protect the human rights of child victims of sale and sexual exploitation.

2022 Wrapped: SAFE Online Highlights

Country Visit of UN Special Rapporteur on the Sale and Sexual Exploitation of Children, Ms. Mama Fatima Singhateh (November 30, 2022)

During her visit, the UN Special Rapporteur convened a closed-door meeting with Plan International child and youth facilitators to know their feelings and learnings, and the challenges they face on the sale of children, child prostitution and child pornography.

Four (4) Youth Facilitators from Barangay Molino II, Bacoor City have had the opportunity to discuss the issues and experiences of children related to cyber safety and campaign against OSEC as advocates, with the United Nations Special Rapporteur on the Sale and Exploitation of Children, including child prostitution, child pornography, and other child sexual abuse material, Ms. Mama Fatima Singhateh.

Jhasper, 16 years old, share one of the questions asked during the discussion -

We are also asked about our opinion on solutions-recommendations and we share that not only children in school but street children should be taught about their rights including cyber safety and protection, and there are parents who neglect their child/children some are not prioritized by their family, not properly guided by parents, or no time at all.
