1. General Terms & Condition:

- Plan International Nepal has fully paid the customs duty for all vehicles, status of renewal the blue books, and obtained comprehensive insurance as specified in the details sheet (Annex B of the tender document).
- The vehicles will be sold on an "as is, where is" basis without recourse. Inspection is available from May 9th to 20th, 2025 (10:00 am to 04:00 pm, Monday to Friday, except holidays) at Plan International Nepal at the respective location of Country Office in Kathmandu, Regional Office-Janakpur, and Western Regional Office-Surkhet. Refer to Annex B in the tender documents for vehicle locations.
- Interested bidders (individuales, firms, or companies) can collect the bid document during office hours from 9th to 20th May 2025, from any of the three Plan International Nepal offices (addresses below), or download it from: https://plan-international.org/nepal/procurement-nepal.
- The deadline for submission of the tender document May 22nd, 2025, Thursday by 5:00 PM.
- Tender document collection and submission must be in office hour i.e. from 9:00 AM to 05:00

- a. The vehicles will be sold "as is where is" basis without recourse. These vehicles can be inspected from May 9th to 20th, 2025 from 10:00 am to 04:00 pm from Monday to Friday except the Plan holidays in Plan International Nepal Office, at the respective locations of Plan International Offices (Kathmandu, Janakpur and Surkhet at the respective areas where the respective vehicle currently available). Vehicles will be displayed at the respective location for inspection at the respective locations where vehicles are now.
- b. Plan International Nepal reserves rights to reject/cancel any or all bids without assigning any reason or award either fully or partially to different bidders.

- e. Vehicles will be released to the winning bidders only upon the submission of bank deposit voucher in the given bank account within a week of declaration of result.
- f. Winner must take the vehicle from the premises of Plan International Nepal's respective office within a week of submission of bank deposit voucher to the Plan International Nepal Bank account.
- g. The winning bidders will be responsible to pay the cost of transferring the ownership and its other associated cost.
- h. Relevant documents/papers will be handed over to successful bidder/s during handover of these vehicles.
- i. The person authorized by bidder will be allowed to take the delivery. The bidders are required to submit their attested copy of citizen/passport/license and any other document as an evidence of their address/ legal documents.

- m. If the highest bidder does not accept the offer of sale of vehicle/s for any reason whatsoever may be, and withdraws from the bidding, in such case, Plan International Nepal can offer the bid to the second highest bidder (if bidder agree) considering the highest bidding value.
- n. If the bid will not be accepted by the second bidder then Plan International Nepal will reserve the right to take appropriate decision.
- o. The successful bidder must initiate the ownership transfer process within 7 days after full payment. Plan International Nepal will assist with necessary documentation but will not cover any related expenses.
